

Which countries will refund my VAT?

Any country of the European Union and any others that have reciprocal agreements in place. If you are unsure about a certain country then contact us directly to confirm your query.

How often can I recover my VAT?

Servitir can present your VAT claims by quarter, semester or by annual claim depending on the value of the claim. All annual claims must be sent by June 30 of the following year.

Who can recover VAT?

Haluage companies, transport & bus companies, couriers, sole traders, heavy industry, cooperatives etc.

What costs are recoverable?

Fuel, tolls, repairs, exhibitions, hotels, restaurants bills, vehicle rent, telephone & fax costs, taxis, lubricants, truck/car wash, road maps and training courses are some examples.

Is VAT the only tax I can recover?

No! You may also be eligible to recover TIPP (fuel duty tax in France and Belgium) if your vehicles weigh over 7.5 tons.

What does it cost?
